Projects of JK MAASS FOUNDATION

Able Kids Special School

A Special School for the children affected by Cerebral Palsy (CP and Mental Retardation (MR) (Recognized by Government of Tamilnadu) is functioning in Corporation School Complex, Pillaimar Street, Arappalayam, Madurai-625016.

Cerebral Palsy is brain damage that results in delayed development of the affected persons. This special school with well equipped customized rehabilitation equipment is a boon to the poor children affected by CP and MR and their parents in Madurai. This school provides daily activities training for children to lead a near normal life.

Sooryodhayam CP Centre

An Early Intervention Centre for the children affected by Cerebral Palsy and Mental Retardation. This centre is functioning at Pothumbu Main Road, Next to Govt. Hr. Sec. School, Pothumbu, Madurai-625018.

By this Early Intervention Centre, JKMF has proven through various success stories that, identifying disability and providing rehabilitation at the early stage (0 – 8 years of age) brings in remarkable changes in the developmental stages of the children with delayed physical development. This centre prepares the children for the next level of special education both physically and mentally.



Community Based Rehabilitation (CBR)

In villages of Madurai West Block, JKMF focuses on organizing the scattered Persons With Disabilities (PWDs) as a group. This programme creates awareness on the available Government welfare schemes, Income generating sources and Skill development training and rehabilitation services.

Muscular Dystrophy (MD) Day Care centre

A special programme fully supported by Government of Tamilnadu is functioning at Door No. 40, Pillaimar Street, Arappalayam, Madurai-625016.

Muscular Dystrophy is a Genetic disorder that affects the strength of muscles that leads to lack of mobility of the affected persons. Physical therapy is the only rehabilitation solution available for the affected persons. This is the District Centre with specialized equipment that provides physical therapy for strengthening the muscles and improving muscle power of the persons affected by Muscular Dystrophy. This helps them to achieve better mobility. This centre benefits 37 persons affected by Muscular Dystrophy. This is the one of four centres established by Government of Tamilnadu. This Centre provides home care services to those persons who are not in a position to attend the centre.
